Who We Are?

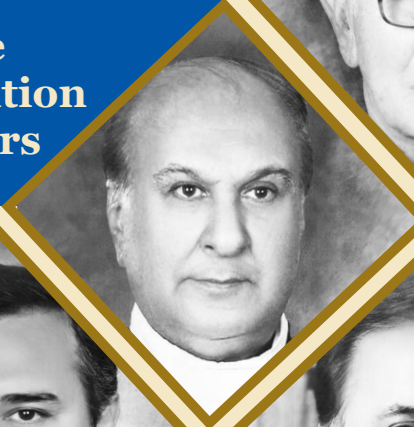

Key Legal Foundations

FBA, like other Iranian bar associations, operates within the national legal framework rather than through an independent charter. Core legal instruments include:

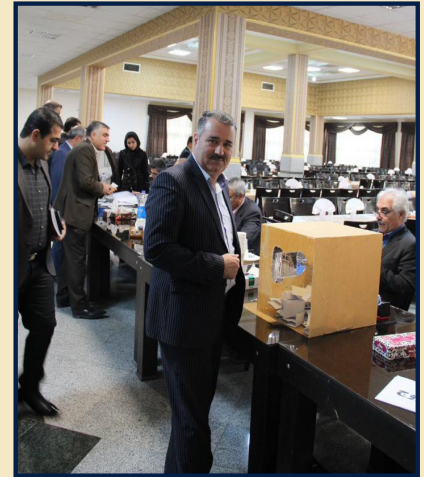
1. The Law on Attorneys (1937) – Defines legal practice criteria.
2. The Independence Law (1954) – Secures autonomy from governmental interference.
3. Executive Bylaw (2021) – Details implementation, governance, and oversight procedures.
4. Law on Licensing (1997) – Regulates entrance exams, internships and licensing.
